State of Kansas Official General Election Ballot Constitutional Amendments County of Thomas November 8, 2016

Instructions

If you tear, deface, or make a mistake and wrongfully mark any ballot, you must return it to the election board and receive a new ballot or set of ballots.

To vote in favor of any question submitted upon this ballot, darken the oval to the left of the word "Yes"; to vote against it, darken the oval to the left of the word "No".

Question Submitted

Constitutional Amendment

Vote Yes or No

Explanatory statement. This amendment is to preserve constitutionally the right of the public to hunt, fish and trap wildlife subject to reasonable laws and regulations. The right of the public to hunt, fish and trap shall not modify any provision of common law or statutes relating to trespass, eminent domain or any other private property rights.

A vote **for** this proposition would constitutionally preserve the right of the public to hunt, fish and trap wildlife that has traditionally been taken by hunters, trappers and anglers. This public right is subject to state laws and rules and regulations regarding the management of wildlife and does not change or diminish common law or statutory rights relating to trespass, eminent domain or private property.

A vote **against** this proposition would provide for no constitutional right of the public to hunt, fish and trap wildlife. It would maintain existing state laws and rules and regulations governing hunting, fishing and trapping wildlife.

Shall the following be adopted?

§21. Right of public to hunt, fish and trap wildlife. The people have the right to hunt, fish and trap, including by the use of traditional methods, subject to reasonable laws and regulations that promote wildlife conservation and management and that preserve the future of hunting and fishing. Public hunting and fishing shall be a preferred means of managing and controlling wildlife. This section shall not be construed to modify any provision of law relating to trespass, property rights or water resources.''

THOMAS COUNTY, KANSAS CRIMINAL JUSTICE CENTER

Shall the following be adopted?

Shall Thomas County, Kansas, be authorized to: (1) impose a one-half percent (1/2%) retailers' sales tax (the "Sales Tax") for the purpose of financing the cost to construct, furnish and equip a new Thomas County Criminal Justice Center, including a new jail, law enforcement offices, county attorney offices, court room facilities, court services, district court clerk, community corrections, parking and all improvements appurtenant thereto (collectively the "Project"), collection of such Sales Tax to commence on April 1, 2017, or as soon thereafter as permitted by law, and to expire upon the payment of all costs incurred in the financing of the Project (including the retirement of any bonds issued and payable from such sales tax); and (2) issue sales tax/general obligation bonds (the "Bonds") in an amount not to exceed \$15,000,000 to pay a portion of the estimated \$15,300,000 costs of the Project, related interest costs during construction and issuance costs, the balance of the estimated costs of the Project in the amount of \$300,000 will be supplied from monies available to the Thomas County Sheriff through forfeiture funds; provided that the County receive, prior to such bond issuance, a comprehensive feasibility study that indicates the revenues received from such Sales Tax will be sufficient to retire such Bonds without the necessity of levying any ad valorem taxation; all pursuant to the authority of K.S.A. 12-187 et seq., as amended?

ROVOHL TOWNSHIP ROAD MAINTENANCE

Shall the following be adopted?

"Shall Rovohl Township turn over the maintenance, repair and construction of the township roads to Thomas County for a period of twenty (20) years pursuant to KSA 68-560?"
